WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
	within the exclusive control of the Tohono O'odham Nation and to
	appropriate these funds for the benefit of the nation and its members"
	(Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and
WHEREAS,	the Investment Committee of the Tohono O'odham Nation provides oversight for
	the financial investments of the Nation; and
WHEREAS,	based on the recommendation of the Investment Committee, the Legislative
	Council has for some years selected the Bank of America as the custodian and
	manager of the Nation's invested funds; and
WHEREAS,	in FY 2009, the Nation retained Portfolio Evaluations, Inc. as an independent
	investment consultant to advise the Nation regarding the investment choices
	made or recommended by the Bank of America and by any subsequent or
	additional investment advisors that may be retained by the Nation; and
WHEREAS,	under the contract, the investment consultant will report as reasonably
	necessary to the Investment Committee and will, at a minimum, provide two
	presentations per year to the full Legislative Council; and
WHEREAS,	the term of the contract will be from October 1, 2016 through September 30,
	2017, and the financial arrangement will be a flat retainer fee for services
	relating to the Nation's investment portfolio and the 401(k) retirement plan; and
WHEREAS,	the source of funds for the consultant fee will be the investment accounts of the
	Nation; and
WHEREAS,	the Investment and Budget and Finance Committees have reviewed the contract
	and recommend its approval.
NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
	1. Approves the FY 2017 Investment Consultant Contract with Portfolio
	Evaluations, Inc.; and
	2. Approves the consultant fees to be paid from the investment accounts of
