

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Office of Attorney General Budget Amendment No. 1)**

RESOLUTION NO. 16-583

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Office of Attorney General Budget in the amount of \$1,989,446.32 was**
8 **approved by Resolution No. 16-322; and**

9 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**
10 **approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**
11 **reference and which will adjust operational line items; and**

12 **WHEREAS, the FY 2017 Office of Attorney General Budget Amendment No. 1 will increase the**
13 **FY 2017 Office of Attorney General by \$545,000.00 from \$1,989,446.32 to**
14 **\$2,534,446.32; and**


15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
16 **2017 Office of Attorney General Budget Amendment No. 1 and recommends its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2017 Office of Attorney General Budget Amendment No. 1, which includes a**
20 **\$545,000.00 increase from \$1,989,446.32 to \$2,534,446.32 that shall be funded in**
21 **the amount of \$200,000.00 from the FY 17 Self-Governance Start-up Fund and in**
22 **the amount of \$345,000.00 from the Nation's FY 2017 General Fund Surplus.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation chairperson or any designated official is authorized to**
25 **administer and expend the FY 2017 Office of Attorney General Budget as**
26 **amended, provided however, that any amendments or modifications shall be**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
