8		the potential transition of Bureau of Indian Education operated schools to tribal				
9		schools, and preparation of statutory and regulatory institutions to govern				
10		schools on the Nation's lands; for the period of December 7, 2016 to September				
11		30, 2017; and				
12	WHEREAS,	the Domestic Affairs Committee has reviewed the FY 2017 attorney contract with				
13		the Law Firm of Hobbs Straus Dean & Walker and recommends approval by the				
14		Legislative Council.
