

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting December 14, 2016 Special Session for Summary Judgment Hearing in**  
**United States District Court in Phoenix, Arizona)**

**LEGISLATIVE ORDER NO. 16-587**

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and  
2 procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees." (Constitution of the Tohono  
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council  
6 with the authority to "by majority vote, call for a special session" (Legislative  
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 **WHEREAS,** the Economic Development Delegation has requested a special session on  
9 December 14, 2016 for the summary judgment hearing in the United States  
10 District Court in Phoenix, Arizona with roll call beginning at 1:00 p.m. at Veridus.

11 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a  
12 special session on December 14, 2016 for the summary judgment hearing in the  
13 United States District Court in Phoenix, Arizona with roll call beginning at 1:00  
14 p.m. at Veridus.


15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> day of**

20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat.984).**
