

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 99-200, 99-311, 99-360, and 02-569 to  
Correct Names of Enrolled Members)**

**RESOLUTION NO. 16-590**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
11 **O'odham Legislative Council shall determine whether an application is**  
12 **approved for membership and its determination, along with the resolution**  
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
15 **approving membership and adoption applications misspelled or incorrectly**  
16 **listed the names of members; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 99-200, 99-**  
18 **311, 99-360, and 02-569 be amended to reflect the correct name for the members**  
19 **identified in the December 2016 Corrected Enrollment Resolution Summary,**  
20 **which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
22 **Resolution Nos. 99-200, 99-311, 99-360, and 02-569 are amended upon the**  
23 **effective date of those resolutions to reflect the correct name for the members**  
24 **identified in the December 2016 Corrected Enrollment Resolution Summary.**


25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**

30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**






