

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Camillus Lopez to the Election Board to Complete a Five-Year Term
Ending July 31, 2021)**

RESOLUTION NO. 16-591

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to "provide for, appoint, or provide for the appointment of, and**
3 **prescribe the duties and powers of committees, boards, officers and agents"**
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(b)); and**

5 **WHEREAS, the Nation's Elections law, codified at 12 Tohono O'odham Code, Chapter 1,**
6 **authorizes the Tohono O'odham Legislative Council to appoint members of the**
7 **Tohono O'odham Election Board (12 T.O.C. Chapter 1, Article III, Section**
8 **1301(B)); and**


9 **WHEREAS, the Nation's Elections law provides that board members shall be "appointed . . .**
10 **for a term of five years or until their successors are appointed" and further that**
11 **"[a]ppointments to the Board shall be staggered so that the term of office of only**
12 **one member will end in any single year." (12 T.O.C. Chapter 1, Article III, Section**
13 **1301(B)); and**

14 **WHEREAS, the Rules Committee recommends that Camillus Lopez be appointed to the**
15 **Election Board to complete a term ending July 31, 2021.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **appointment of Camillus Lopez to the Election Board beginning on the effective**
18 **date of this resolution and ending July 31, 2021; provided that he shall continue**
19 **to serve until a successor is appointed.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
21 **day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
22 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(b); Article X, Section 7 of the Constitution of the Tohono O'odham Nation,**
24 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
25 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
26 **16 of the Act of June 18, 1934 (48 Stat.984).**
