

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Division of
Community Health Services Comprehensive Cancer Control Budget)

RESOLUTION NO. 16-593

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation received award notices from the Cancer Prevention**
8 **and Control Program for State, Territorial and Tribal Organizations grant in the**
9 **amount of \$196,534.00 for the fifth year of a five-year funding cycle for the**
10 **period of June 30, 2016 through June 29, 2017; and**

11 **WHEREAS, the Department of Health and Human Services Division of Community Health**
12 **Services has prepared and submitted for review and approval its FY 2017**
13 **Comprehensive Cancer Control Budget, which is incorporated by this reference,**
14 **in the amount of \$196,534.00, to be funded from the Cancer Prevention and**
15 **Control Program for State, Territorial and Tribal Organizations grant; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2017 Department of Health and Human Services Division of**
18 **Community Health Services Comprehensive Cancer Control Budget and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 Department of Health and Human Services Division of Community**
22 **Health Services Comprehensive Cancer Control Budget effective June 30, 2016 in**
23 **the amount of \$196,534.00, which shall be funded by the Cancer Prevention and**
24 **Control Program for State, Territorial and Tribal Organizations grant and**
25 **authorizes the use of Nation's resources pending reimbursement from the**
26 **grantor.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
28 **O'odham Nation chairperson or any designated official is authorized to**
29 **administer and expend the FY 2017 Department of Health and Human Services**
30 **Division of Community Health Services Comprehensive Cancer Control Budget,**
