

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Dialysis Patient
Advocacy Budget Amendment No. 1)

RESOLUTION NO. 16-594

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the FY 2017 Department of Health and Human Services ("DHHS") Dialysis Patient**
8 **Advocacy Budget in the total amount of \$84,048.00 was approved by Resolution**
9 **No. 16-322; and**

10 **WHEREAS, the DHHS has prepared and submitted for review and approval its FY 2017**
11 **Budget Amendment No. 1, which is incorporated by reference, and which will**
12 **adjust operational line item: client support, by adding additional narrative**
13 **language for program activities and events; and**

14 **WHEREAS, the FY 2017 DHHS Dialysis Patient Advocacy Budget Amendment No. 1 will not**
15 **change the budget amount approved in Resolution No. 16-322; and**

16 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
17 **Legislative Council reviewed the FY 2017 DHHS Dialysis Patient Advocacy Budget**
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 DHHS Dialysis Patient Advocacy Budget Amendment No. 1, which does**
21 **not change the budget amount approved by Resolution No. 16-322.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Chairperson or any designated official is authorized to administer and**
24 **expend the FY 2017 DHHS Dialysis Patient Advocacy Budget as amended,**
25 **provided however, that further amendments or modifications shall be**
26 **submitted to the Tohono O'odham Legislative Council for prior approval.**


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**

31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
