LEGISLATIVE ORDER NO. 17-001

1	WHEREAS,	The Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "enact laws and ordinances for conducting and regulating
3		elections" and provides that the "decision of the Tohono O'odham Council in all
4		election matters, including the eligibility and qualifications of candidates, shall
5		be final" (Constitution, Article VI, Section 1(g) and Article X, Section 7); and
6	WHEREAS,	the Legislative Council alternate seat to Sells District Representative Barbara
7		Havier has remained vacant; and
8	WHEREAS,	pursuant to 12 Tohono O'odham Code Chapter 1, Section 1505(B)(3), when a
9		Legislative Council alternate's seat is vacant, a district may "adopt a resolution
10		appointing an alternate who shall hold office for the unexpired term of his
11		predecessor; provided that the alternate shall not be seated until the Board
12		certifies in writing that the alternate meets all the qualifications for that office.";

14	WHEREAS,	on November 10, 2016, the Sells District Council appointed Idaleen Reyes to serve
15		as alternate to Legislative Representative Barbara Havier on the Legislative
16		Council (Sells District Council Resolution No. SD-92-16); and
17	WHEREAS,	on December 15, 2016, the Election Board certified in writing that Idaleen Reyes
18		meets all the qualifications for the office of Legislative Council alternate (12
19		Tohono O'odham Code, Section 11206(C)); and
20	WHEREAS,	the Legislative Council, as a means of ensuring the orderly transition of public
21		office, has recognized by legislative order district council appointments to
22		vacancies that are made in accordance with 12 Tohono O'odham Code Chapter 1.
23	NOW, THER	EFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it
24		recognizes the Sells District Council appointment of Idaleen Reyes to serve as
25		alternate to Legislative Council Representative Barbara Havier, who shall serve
26		in accordance with the Constitution and laws of the Tohono O'odham Nation and
27		the rules and procedures of the Legislative Council when Representative Barbara
28		Havier is unable to attend a Legislative Council session.
