9		Arizona Health Care Cost Containment System ("AHCCCS") to provide Arizona
10		Long Term Care Systems ("ALTCS") case management services to eligible

12	WHEREAS,	the Tohono O'odham Nation has provided ALTCS case management services
13		since June 1996 and is compensated from the State of Arizona for the services;

15	WHEREAS,	the Intergovernmental Agreement Amendment No. 3 incorporates the CYE 17
16		Case Management Rates; and amends Attachment A, with an effective date of
17		October 1, 2016; and
18	WHEREAS,	the Health and Human Services Committee has reviewed Amendment No. 3 to
19		the Intergovernmental Agreement between AHCCCS and the Tohono O'odham
20		Nation and recommends its approval.
