

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Legislative Order No. 15-228, "Certifying Elections of Council Representatives to the Legislative Council Standing Committees, Certifying Committee Officers, and Seating Council Representatives to Committee Memberships" and Legislative Order No. 15-241, "Adopting 2015-2017 Legislative Council Committee Meeting Schedule" to Reflect Election of Standing Committee Officers and Change in Committee Membership)**

**LEGISLATIVE ORDER NO. 17-073**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish**  
2 **rules and procedures to regulate all meetings of the Council and its standing**  
3 **committees (Constitution, Article VI, Section 1(a)); and**

4 **WHEREAS, on June 12, 2015, the Legislative Council elected committee members and officers**  
5 **to the twelve standing committees in accordance with Article XII, Section 3 of the**  
6 **Legislative Rules (Legislative Order No. 15-228); and**

7 **WHEREAS, Rep. Lucinda J. Allen was elected Legislative Council vice-chairperson, thereby**  
8 **leaving the committee officer and membership positions she had held vacant**  
9 **(Legislative Order No. 17-038); and**

10 **WHEREAS, pursuant to Legislative Rules Article XII, Section 3(J), the Domestic Affairs and**  
11 **Water Resources each held caucuses to fill committee officer seats left vacant by**  
12 **Rep. Lucinda J. Allen's election as Legislative Council vice-chairperson.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that Legislative**  
14 **Order No. 15-228 is amended to reflect the following committee officers elected**  
15 **to vacant seats by the standing committees:**

18 **Water Resources:**

19 **Representative Quintin C. Lopez, Chairman**

20 **Representative Mary Lopez, Vice-Chairperson**

21 **BE IT FURTHER ORDERED by the Tohono O'odham Legislative Council that Legislative Order No.**  
22 **15-241, "Adopting 2015-2017 Legislative Council Committee Meeting Schedule" is**  
23 **amended to reflect changes to committee officers and committee membership.**


24 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> day of**


