

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Education, Special Services Program, Individuals
with Disabilities Education Act Part B Budget Amendment No. 1)

RESOLUTION NO. 17-099

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Education, Special Services Program, Individuals**
8 **with Disabilities Education Act ("IDEA") Part B Budget, in the amount of**
9 **\$367,543.89, was approved by Resolution No. 16-326; and**

10 **WHEREAS, the Tohono O'odham Legislative Council approved the use of \$79,896.21 in FY**
11 **2015 carry forward savings to be included in the FY 2017 Department of**
12 **Education Special Services IDEA Part B Budget through Resolution No. 16-205;**
13 **and**

14 **WHEREAS, the Department of Education Special Services Program prepared and submitted**
15 **for review and approval its FY 2017 IDEA Part B Budget Amendment No. 1, which**
16 **is incorporated by this reference, and which will adjust operational line items;**
17 **and**

18 **WHEREAS, the FY 2017 Department of Education Special Services Program IDEA Part B**
19 **Budget Amendment No. 1 will increase the FY 2017 Department of Education**
20 **Special Services Program IDEA Part B Budget by \$79,896.21 from \$367,543.89 to**
21 **\$447,440.10; and**

22 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
23 **have reviewed the FY 2017 Department of Education Special Services Program**
24 **IDEA Part B Budget Amendment No. 1 and recommend its approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
26 **the FY 2017 Department of Education Special Services Program IDEA Part B**
27 **Budget Amendment No. 1, which includes a \$79,896.21 increase from**
28 **\$367,543.89 to \$447,440.10 that shall be funded by FY 2015 carry forward savings**
29 **from the Bureau of Indian Affairs grant funds.**

4 **Program IDEA Part B Budget as amended, provided however, that any**
5 **amendments or modifications shall be submitted to the Tohono O'odham**
6 **Legislative Council for prior approval.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
8 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [09] ABSENT, pursuant to the powers vested in the Council by**
10 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
11 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
13 **June 18, 1934 (48 Stat.984).**


