

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Education, Education Administration Budget
Amendment No. 1)

RESOLUTION NO. 17-100

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY2017 Department of Education, Education Administration Budget in the**
8 **amount of \$500,180.36 was approved by Resolution No. 16-322; and**

9 **WHEREAS, the Department of Education, Education Administration has prepared and**
10 **submitted for review and approval its FY 2017 Budget Amendment No. 1, which is**
11 **incorporated by this reference and which (1) will adjust operational line items;**
12 **(2) add new line item 7110 Communication Expense; and**

13 **WHEREAS, the FY 2017 Department of Education, Education Administration Budget**
14 **Amendment No. 1 will not increase the overall budgeted amount of \$500,180.36;**
15 **and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2017 Department of Education, Education Administration**
18 **Budget Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 Department of Education, Education Administration Budget**
21 **Amendment No. 1 which will add a new line item 7110 Communication Expense**
22 **with no increase to the overall budgeted amount of \$500,180.36.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation chairperson or any designated official is authorized to**
25 **administer and expend the FY 2017 Department of Education, Education**
26 **Administration Budget as amended, provided however, that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**






