

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting May 17, 2017 Special Session to Address Appointments to the Economic  
Development Authority Board of Directors, Tohono O'odham Utility Authority  
Management Board and Gaming Office Executive Director)**

**LEGISLATIVE ORDER NO. 17-198**

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and  
2 procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees." (Constitution of the Tohono  
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council  
6 with the authority to "by majority vote, call for a special session" (Legislative  
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 **WHEREAS,** the Commerce Committee has requested a special session on May 17, 2017 to  
9 address the appointment of candidates for the following.

- 10 1. Economic Development Authority Board of Directors
- 11 2. Tohono O'odham Utility Authority Management Board
- 12 3. Gaming Office Executive Director

13 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a  
14 special session on May 17, 2017 to address appointments to the Economic  
15 Development Authority Board of Directors, Tohono O'odham Utility Authority  
16 Management Board and Gaming Office Executive Director.

17 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of  
18 MAY 2017 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0- AGAINST;  
19 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,  
20 Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian  
22 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
23 Stat.984).
