1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the power to "negotiate and conclude agreements and contracts on behalf of the
3		Tohono O'odham Nationwith private persons or organizations on all matters
4		within the authority of the Tohono O'odham Council" (Constitution, Article VI,
5		Section 1(f)); and
6	WHEREAS,	the Council has prescribed the duties and powers of the Council Chairman and
7	ľ	Vice Chairman (collectively, "legislative officers") by adopting the Legislative
8		Rules and by passing Legislative Order No. 06-047, "Amended Delegation of
9		Authority to Legislative Council Chairperson and Vice Chairperson"; and
10	WHEREAS,	although Legislative Order No. 06-047 expressly delegates to the legislative
11		officers the authority to negotiate, execute, and administer certain contracts, the
12		officers are not authorized to enter contracts that "indemnify a third party or
13		authorize payment of an award of attorney fees or costs of litigation or
14	1	arbitration, unless previously authorized by a majority vote of the Legislative
15		Council"; and
16	WHEREAS,	at the request of the legislative officers, staff researched and identified a new web
17		hosting service, Bluehost to provide services to the Legislative Branch; and
18	WHEREAS,	although the Bluehost "Terms of Service" does not expressly require the
19		Legislative Branch to waive its sovereign immunity, it does include
20		indemnification clauses and other provisions which require Legislative Council
21		approval.
22	NOW, THER	EFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it
23		authorizes the Legislative Council officers to accept and execute the Bluehost
24		"Terms of Service," provided that nothing in this delegation or in the agreement
25		shall be deemed a waiver of the Nation's sovereign immunity or legislative
26		immunity.
