1	WHEREAS,	on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
2		"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
3		per capita payments to the Nation's members provided that sufficient gaming
4		revenues are available; and
5	WHEREAS,	the Ordinance for the Regulation of Gaming Activities Within the Tohono
6		O'odham Nation (the "Gaming Ordinance") was subsequently amended to
7		authorize per capita distribution payments in accordance with the Initiative
8		(Legislative Council Resolution No. 97-303); and
9	WHEREAS,	the Legislative Council did adopt the Second Revenue Allocation Plan and
10		Amendment No. 1 to the Second Revenue Allocation Plan pursuant to Legislative
11		Council Resolution Nos. 2000-269 and 2000-472, respectively; and
12	WHEREAS,	on October 25, 2000, the Deputy Commissioner of Indian Affairs approved the
13		Second Revenue Allocation Plan as amended; and
14	WHEREAS,	the Tohono O'odham Nation Enrollment Office submitted to the Tohono O'odham
15		Legislative Council the Certification of Eligible Members for the second per capita
16		distribution for review and approval; and
17	WHEREAS,	Legislative Council approved the Certification of Eligible Members for the second
18		per capita distribution, with the initial number of 12,716 verified adult members
19		(Resolution Number 2000-517); and
20	WHEREAS,	the disbursement of funds to each eligible adult member is contingent upon
21		verification of a member and certification by the Tohono O'odham Legislative
22		Council; and
23	WHEREAS,	the Tohono O'odham Department of Membership Services has submitted a
24		certification listing of two verified adult members who is listed on the previously
25		approved Certification of Eligible Members and are eligible to receive the second
26		per capita payment.
27	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
28		1. Approves the verification and certification of two adult members listed on
29		the attached June 2017 Certification Listing of an Adult Members for the
30		Second Per Capita Distribution.
31		2. Approves the distribution of \$2,000, less any applicable taxes required by
32		federal law, to the adult member listed.

3. Authorizes the Chairperson of the Nation or a designated official to execute such other documents as may be necessary to implement this resolution.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of funds to additional eligible Tohono O'odham adult members is contingent upon verification of membership by the Tohono O'odham Department of Membership Services and certification by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
