17	((1) If on an application for adoption, the date of applicant's birth and, the
18		degree of Papago - Tohono O'odham Indian blood ascribed to the
19		applicant.
20	((2) If on an application for enrollment, the date of applicant's birth, the
21		membership requirement or requirements which the Tohono O'odham
22		Council found the applicant did or failed to establish.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has

27		enrollment number, and membership requirement or, for adoption, the degree
