

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Planning Department Credit and Finance Program  
BIA P.L. 93-638 Budget Amendment No. 1)**

**RESOLUTION NO. 17-303**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Planning Department Credit and Finance Program BIA P.L. 93-638  
8 Budget in the amount of \$293,380.23 was approved by Resolution No. 16-326; and

9 **WHEREAS,** the Credit and Finance Program has prepared and submitted for review and  
10 approval its FY 2017 Budget Amendment No. 1, which is incorporated by this  
11 reference and which will adjust operational and/or personnel line items; and

12 **WHEREAS,** the FY 2017 Planning Department Credit and Finance Program BIA P.L. 93-638  
13 Budget Amendment No. 1 will decrease the Credit and Finance Program FY 2017  
14 BIA P.L. 93-638 Budget by \$699.25 from \$293,380.23 to \$292,680.98; and

15 **WHEREAS,** the Commerce and Budget and Finance Committees have reviewed the FY 2017  
16 Planning Department Credit and Finance Program BIA P.L. 93-638 Budget  
17 Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
19 FY 2017 Planning Department Credit and Finance Program BIA P.L. 93-638 Budget  
20 Amendment No. 1, which includes a \$699.25 decrease from \$293,380.23 to  
21 \$292,680.98.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
23 Nation chairperson or any designated official is authorized to administer and  
24 expend the FY 2017 Planning Department Credit and Finance Program BIA P.L.  
25 93-638 Budget as amended, provide however, that any amendments or  
26 modifications shall be submitted for prior approval by the Tohono O'odham  
27 Legislative Council.

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
29 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 2,853.5 FOR; 231.1**  
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
