

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting the FY 2017 Title IV-B Subpart 1 and Title IV-B Subpart 2 award from the
U.S. Department of Health and Human Services Administration for Children and
Families and Approving the FY 2017 Department of Health and Human Services Child
Welfare Division Title IV-B Subpart 1 and Title IV-B Subpart 2 Budget Amendments No.1)

RESOLUTION NO. 17-320

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d) (2) and (3)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") Child Welfare Division**
8 **Title IV-B, Subpart 1 Budget in the amount of \$89,367.00 and Title IV-B Subpart 2**
9 **Budget in the amount of \$190,666.59 was approved by Resolution No. 16-329; and**

10 **WHEREAS, the Nation received an award from the U.S. Department of Health and Human**
11 **Services Administration for Children and Families for Title IV-B Subpart 1 in the**
12 **amount of \$110,153.00 and an award for Title IV-B Subpart 2 in the amount of**
13 **\$159,795.00; and**

14 **WHEREAS, the DHHS Child Welfare Division has prepared and submitted for review and**
15 **approval its FY 2017 Title IV-B Subpart 1 and Title IV-B Subpart 2 Budget**
16 **Amendments No. 1, which are incorporated by this reference and which will**
17 **adjust personnel and/or operational line items; and**

18 **WHEREAS, the FY 2017 DHHS Child Welfare Division Title IV-B Subpart 1 Budget**
19 **Amendment No. 1 will increase the DHHS Child Welfare FY 2017 Title IV-B**
20 **Subpart 1 Budget by \$20,786.00 from \$89,367.00 to \$110,153.00 and will decrease**
21 **Title IV-B Subpart 2 Budget by \$30,871.59 from \$190,666.59 to \$159,795.00; and**

22 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
23 **reviewed the FY 2017 DHHS Child Welfare Division Title IV-B Subpart 1 and Title**
24 **IV-B Subpart 2 Budget Amendments No. 1 and recommend their approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
26 **award from the U.S. Department of Health and Human Services Administration**
27 **for Children and Families for Title IV-B Subpart 1 in the amount of \$110,153.00**
28 **and an award for Title IV-B Subpart 2 in the amount of \$159,795.00.**

29 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2017**
30 **DHHS Child Welfare Division Title IV-B Subpart 1 Budget Amendment No. 1,**
31 **which includes a \$20,786.00 increase from \$89,367.00 to \$110,153.00 and Title IV-**
32 **B Subpart 2 Budget Amendment No. 1 which includes a decrease of \$30,871.59**
33 **from \$190,666.59 to \$159,795.00, adding new additional line items: 7000**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


