

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Pia-Oik Community Budget Amendment No. 1)**

**RESOLUTION NO. 17-343**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only**  
6 **by a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **;and**

12 **WHEREAS,** the Pia-Oik Community did submit their FY 2017 Budget Amendment No. 1; and

13 **WHEREAS,** the Gu-Vo District Governing Council Resolution No. GV-17-094 amends the FY  
14 2017 budget for the Pia-Oik Community in the amount of \$9,836.60; and

15 **WHEREAS,** Pursuant to Gu-Vo District Council Resolution No. GV-17-094, the Gu-Vo District  
16 has prepared and submitted for review and approval its FY 2017 Pia-Oik  
17 Community Budget Amendment No. 1 which is incorporated by this reference  
18 which will adjust Personnel and Operational Line Items; and

19 **WHEREAS,** the Budget and Finance Committee of the Legislative Council has reviewed the  
20 FY 2017 Pia-Oik Community Budget Amendment No. 1 and recommends its  
21 approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby  
23 **approves the Pia-Oik Community FY 2017 Budget Amendment No. 1 in the**  
24 **amount of \$9,836.60 which is incorporated by this reference which will adjust**  
25 **Personnel and Operational Line Items.**

26 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes the District  
27 **Chairperson and any designated official to expend and administer the budget as**  
28 **attached, provided that any amendments affecting the funds or funding level is**  
29 **submitted for further prior approval by the Tohono O'odham Legislative**
