LEGISLATIVE ORDER NO. 17-388

2		Council to "enact laws and ordinances for conducting and regulating elections"
3		and provides that the "decision of the Tohono O'odham Council in all election
4		matters, including the eligibility and qualifications of candidates, shall be final"
5		(Constitution, Article VI, Section 1(g) and Article X, Section 7); and
6	WHEREAS,	since May 2017, the Legislative Council alternate seat to San Lucy District
7		Representative Jana Montana has remained vacant; and
8	WHEREAS,	pursuant to 12 T.O.C. Chapter 1, Section 1505(B)(3), when a Legislative Council
9	·	alternate's seat is vacant, a district may "adopt a resolution appointing an
10		alternate who shall hold office for the unexpired term of his predecessor;
11		provided that the alternate shall not be seated until the Board certifies in
12		writing that the alternate meets all the qualifications for that office"; and
13	WHEREAS,	on July 6, 2017 the San Lucy District Council appointed Diana Manuel to serve as
14		alternate to Legislative Representative Jana Montana on the Legislative Council
15		(San Lucy District Resolution No. SL 07-107-17); and
16	WHEREAS,	by letter dated September 5, 2017, the Election Board has certified in writing
17		that Diana Manuel meets all the qualifications for the office of Legislative
18		Council alternate.
19	NOW, THER	EFORE, BE IT ORDERED that the Tohono O'odham Legislative Council recognizes
20	i	the San Lucy District Council appointment of Diana Manuel to serve as alternate
21	ŀ	to Legislative Representative Jana Montana and seats alternate Diana Manuel,
22		who shall serve in accordance with the Constitution and laws of the Tohono
23		O'odham Nation and with the rules and procedures of the Legislative Council
24		when Representative Jana Montana is unable to attend a Legislative Council
25		session.
