1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council
2		with the power "to consult, negotiate and conclude agreements and contracts on
3		behalf of the Tohono O'odham Nation with Federal, State and local governments
4		and other Indian tribes or their departments, agencies, or political
5		subdivisions, or with private persons or organizations on all matters within the
6		authority of the Tohono O'odham Council." (Constitution Article VI, Section 1(f));

8	WHEREAS,	the Low Income Home Energy Assistance Program ("LIHEAP") is a federally
9		funded program, administered through the Arizona Department of Economic
10		Security ("ADES"), that helps low-income households pay their heating/cooling
11		bills, minimize crises, and make energy costs more affordable; and
12	WHEREAS,	the LIHEAP Intergovernmental Agreement ("IGA") between the Nation and ADES
13		was approved by Resolution No. 16-212 and was amended by Resolution No. 16-
14		516 to add funding to the IGA in the form of a "Case Management Service Budget"
15		for the period of July 1, 2016 through June 30, 2017; and
16	WHEREAS,	FY 2017 Health & Human Services State LIHEAP Budget for July 1, 2016-June 30,
17		2017 in the amount of \$62,572.00 was approved by Resolution No. 16-171 and the
18		FY 2018 Health & Human Services State LIHEAP Budget for July 1, 2017-June 30,
19		2018 in the amount of \$62,572.00 was approved by Resolution No. 17-341; and
20	WHEREAS,	the ADES has submitted LIHEAP IGA Amendment No. 2 to add the Case
21		Management Service Budget to the IGA for the period of July 1, 2017 through
22		June 30, 2018 in the amount of \$62,572.00; and
23	WHEREAS,	the Health and Human Services and the Budget and Finance Committees have
24		reviewed LIHEAP IGA Amendment No. 2 and recommend its approval.
25	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
26		LIHEAP IGA Amendment No. 2 and authorizes the Tohono O'odham Chairperson
27		to execute the LIHEAP IGA Amendment No. 2 in substantially the form attached,
28		provided that any further modifications or amendments shall be submitted for
29		prior approval by the Tohono O'odham Legislative Council.
