

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Holding October 11, 2017 General Session at the Archie Hendricks, Sr.
Skilled Nursing Facility)

LEGISLATIVE ORDER NO. 17-407

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and


5 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative
6 Council, as amended, provides that "[a]ll Legislative Council sessions shall be
7 held at the Tohono O'odham Legislative Council chambers located in Sells,
8 Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the
9 legislative representatives may vote to hold a session in some location other
10 than the chambers located at Sells."; and

11 **WHEREAS,** the Health and Human Services Committee has requested the Legislative
12 Council hold its October 11, 2017 general session at the Archie Hendricks, Sr.
13 Skilled Nursing Facility with roll call beginning at 9:00 a.m.

14 **NOW, THEREFORE, BE IT ORDERED** that the Tohono O'odham Legislative Council will hold its
15 October 11, 2017 general session at the Archie Hendricks, Sr. Skilled Nursing
16 Facility with roll call beginning at 9:00 a.m.

17 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13TH day of
18 **SEPTEMBER, 2017** at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
19 **AGAINST; -0- NOT VOTING; and [02] ABSENT,** pursuant to the powers vested in the Council by
20 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
21 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
23 June 18, 1934 (48 Stat.984).
