RESOLUTION NO. 17-424

1 WHEREAS. pursuant to Article IX. Section 7 of the Constitution of the Tohono O'odham 2 Nation. 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only 6 by a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council.; and 11 WHEREAS. the current fiscal year will expire on September 30, 2017 and the San Lucy 12 District's authority to expend funds appropriated fiscal year 2017 will end on 13 this day; and 14 WHEREAS. by Resolution No. SL 08-147-17, the San Lucy District has requested approval of a 15 continuing resolution authorizing expenditures under the District's current budget beyond the end of fiscal year and until an FY 2018 budget is approved by 16 17 Legislative Council; and 18 WHEREAS. there are sufficient funds in the San Lucy District account to continue District 19 operations. 20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes 21 the San Lucy District to expend funds in accordance with the District's FY 2017 22 budget after September 30, 2017 and until an FY 2018 budget is approved by 23 Legislative Council resolution. 24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15th 25 day of SEPTEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 26 FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[02]</u> ABSENT, pursuant to the powers vested in the 27 Council by Article VI, Section 1(d)(2)of the Constitution of the Tohono O'odham Nation, 28 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting 29 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 30 16 of the Act of June 18, 1934 (48 Stat. 984). 31 32 HONO O'ODHAM LEGISLATIVE COUNCIL 33 34 35 36 37 38
