

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Education Vocational Rehabilitation Program Budget)

RESOLUTION NO. 17-453

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education Vocational Rehabilitation Program has prepared
8 and submitted for review and approval its FY 2018 Department of Education
9 Vocational Rehabilitation Program Budget, which is incorporated by this
10 reference, in the amount of \$450,723.00, to be funded from the Nation's General
11 Fund pending reimbursement from the grantor; and

12 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
13 reviewed the FY 2018 Department of Education Vocational Rehabilitation
14 Program Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2018 Department of Education Vocational Rehabilitation Program Budget
17 effective October 1, 2017 in the amount of \$450,723.00, which shall be funded by
18 the Nation's General Fund pending reimbursement from the grantor, the United
19 States Department of Education.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
21 O'odham Nation chairperson or any designated official is authorized to
22 administer and expend the FY 2018 Department of Education Vocational
23 Rehabilitation Program Budget, provided that any amendments or
24 modifications shall be submitted for prior approval by the Tohono O'odham
25 Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
27 **day of SEPTEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6**
28 **FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
29 **Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
30 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
