

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Robert T. Jones to the Tohono O'odham
Utility Authority Management Board)

RESOLUTION NO. 17-516

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers**
3 **of committees, boards, officers and agents" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 1(b)); and**

5 **WHEREAS, the Second Restated Plan of Operation of the Tohono O'odham Utility Authority**
6 **("TOUA Plan of Operation"), 24 Tohono O'odham Code Chapter 1, was adopted by**
7 **Resolution No. 91-175; and**

8 **WHEREAS, Section 9 of the TOUA Plan of Operation provides that the Chairman of the Nation**
9 **appoint Directors to the Management Board of the Tohono O'odham Utility**
10 **Authority, subject to approval by the Legislative Council; and**

11 **WHEREAS, Section 9(C)(2) of the TOUA Plan of Operation states that after initial staggered**
12 **terms, all terms shall be for three years starting on the first day of November of**
13 **the year of their respective appointments; and**

14 **WHEREAS, a vacancy exists on the TOUA Management Board; and**

15 **WHEREAS, the Chairman has appointed Robert T. Jones, subject to Legislative Council**
16 **approval, to fill the vacancy with a term set to expire on October 31, 2020; and**

17 **WHEREAS, the Commerce and Rules Committees have reviewed the Chairman's**
18 **appointment.**

19 **NOW, THEREFORE, BE IT RESOLVED that notwithstanding Section 9(C)(2) of the TOUA Plan of**
20 **Operation, the Tohono O'odham Legislative Council approves the appointment of**
21 **Robert T. Jones to the Management Board of the Tohono O'odham Utility**
22 **Authority for a term that shall commence on the effective date of this resolution**
23 **and expire on October 31, 2020, provided that Mr. Jones shall hold office until his**
24 **successor has been appointed and qualified.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH**
26 **day of OCTOBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(b) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**


