

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting November 30, 2017 Special Session for a tour of the Nation's Desert**  
**Diamond Casino and Entertainment in Why, Arizona)**

**LEGISLATIVE ORDER NO. 17-522**

**WHEREAS,** the Legislative Council is vested with the power "to establish rules and procedures to regulate all meetings of the Tohono O'odham Council, standing committees, boards and special committees." (Constitution of the Tohono O'odham Nation, Article VI, Section 1(a)); and

**WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with the authority to "by majority vote, call for a special session" (Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

**WHEREAS,** the Commerce Committee has requested a special session on November 30, 2017 for a tour of the Nation's Desert Diamond Casino and Entertainment in Why, Arizona.

**NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a special session on November 30, 2017 at 10:00 a.m. for a tour of the Nation's Desert Diamond Casino and Entertainment in Why, Arizona.

**The foregoing Order was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup> day of OCTOBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
