

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an FY 2018 Attorney Contract with the Law Office of Sonosky,
Chambers, Sachse, Miller & Monkman, LLP)

RESOLUTION NO. 17-524

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "employ legal counsel for the protection and advancement of the**
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the Law Office of**
6 **Sonosky, Chambers, Sachse, Miller & Monkman, LLP to provide legal advice and**
7 **representation to the Tohono O'odham Nation's Office of Attorney General in**
8 **matters relating to the Nation's Public Law 93-638 contract with the Indian Health**
9 **Services for the period of October 1, 2017 to September 30, 2018; and**

10 **WHEREAS, fees for services under this contract will paid by the Tohono O'odham Nation's**
11 **Office of Attorney General's operating budget; and**

12 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2018 attorney contract with**
13 **the law office of Sonosky, Chambers, Sachse, Miller & Monkman, LLP and**
14 **recommends approval by the Legislative Council.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2018 attorney contract with the law office of Sonosky, Chambers, Sachse, Miller**
17 **and Monkman, LLP and authorizes the chairperson of the Tohono O'odham**
18 **Nation to execute it in substantially the form attached.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH**
20 **day of OCTOBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
21 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat.984).**


