

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an FY 2018 Attorney Contract with California Indian Legal Services)**

RESOLUTION NO. 17-525

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "employ legal counsel for the protection and advancement of the**
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General continues to require the legal services of the**
6 **California Indian Legal Services to represent the Tohono O'odham Nation in legal**
7 **proceedings in California involving the Nation's interests under the Indian Child**
8 **Welfare Act for the period of October 1, 2017 to September 30, 2018; and**

9 **WHEREAS, fees for services under this contract will be paid by the Tohono O'odham Nation's**
10 **Office of Attorney General's operating budget; and**

11 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2018 attorney contract with**
12 **California Indian Legal Services and recommends approval by the Legislative**
13 **Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2018 attorney contract with California Indian Legal Services and authorizes**
16 **the chairperson of the Tohono O'odham Nation to execute it in substantially the**
17 **form attached.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH**
19 **day of OCTOBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
20 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat.984).**
