

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Professional Services Agreement between ScriptPro USA, Inc. and
the Tohono O'odham Nation)

RESOLUTION NO. 17-554

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political**
5 **subdivisions, or with private persons or organizations on all matters within the**
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**
7 **1(f)); and**

8 **WHEREAS, the purpose of this Agreement is to continue a Professional Services Agreement**
9 **between the Tohono O'odham Nation and ScriptPro USA, Inc. for contract**
10 **services for the Tohono O'odham Nation Health Care (TONHC) Pharmacy related**
11 **to prescription disbursement and inventory management; and**

12 **WHEREAS, the Professional Services Agreement between the Tohono O'odham Nation and**
13 **ScriptPro USA, Inc. is necessary for TONHC accreditation, compliance and**
14 **auditing purposes; and**

15 **WHEREAS, entering into the Agreement will provide continuity in the management of**
16 **TONHC pharmacy services; and**

17 **WHEREAS, the Health and Human Services Committee of the Legislative Council has**
18 **reviewed the Professional Services Agreement between ScriptPro USA, Inc. and**
19 **the Nation and recommend it's approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
21 **approves this Professional Services Agreement between ScriptPro USA, Inc., and**
22 **the Tohono O'odham Nation, substantially in the form attached hereto, and**
23 **authorizes the Chairperson of the Nation to sign this Agreement.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
25 **day of NOVEMBER, 2017 at a meeting at which a quorum was present with a vote of 2,782.75**
26 **FOR; 301.85 AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
27 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**
