13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members and/or incorrectly listed enrollment numbers; and
16	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 366-85, 98-
17		429, 99-475, 2000-147, 2000-343, 01-133, 01-050, 01-589, 2000-035, 04-291, 04-438,
