1 WHEREAS, Section 1(a) of Article II of the Constitution of the Tohono O'odham Nation 2 provides that the Tohono O'odham Council can make additions and changes to 3 the official census rolls of the Sells and Gila Bend Reservations dated January 1, 4 1937, and of the San Xavier Reservation dated January 1, 1940, subject to the 5 approval of the Secretary of the Interior; and 6 WHEREAS, the Enrollment Program has identified a number of resolutions approving 7 members as base roll additions that misspelled or incorrectly listed the names of 8 members and/or incorrectly listed enrollment numbers; and 9 WHEREAS. the Enrollment Program therefore recommends that Resolution Nos. 76-83, 28-10 84, 41-84, and 908-85, be amended in part to reflect the correct name and/or 11 enrollment number for the members identified in the attached Amending 12 Enrollment Resolution Summary, which is incorporated by this reference. NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution 13 14 Nos. 76-83, 28-84, 41-84, and 908-85 are amended upon the effective date of those 15 resolutions to reflect the correct name and/or enrollment number for the 16 members identified in the Amending Enrollment Resolution Summary. 17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the ${f 15}^{
