

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an FY 2018 Attorney Contract with the Law Firm of Garvey, Schubert & Barer)

RESOLUTION NO. 17-565

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "employ legal counsel for the protection and advancement of the**
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of Garvey,**
6 **Schubert & Barer to provide legal advice and representation to the Tohono**
7 **O'odham Nation's Office of Attorney General in matters involving the O'odham**
8 **Hewel Ni'ok and the Federal Communications Commission for the period of**
9 **October 1, 2017 to September 30, 2018; and**

10 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2018 attorney contract with**
11 **the law firm of Garvey, Schubert & Barer and recommends approval by the**
12 **Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2018 attorney contract with the law firm of Garvey, Schubert & Barer and**
15 **authorizes the chairperson of the Tohono O'odham Nation to execute it in**
16 **substantially the form attached.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
18 **day of NOVEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR**
19 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat.984).**
