12		Services has prepared and submitted for review and approval its FY 2018 Public
13		Health Preparedness State Zika Program Budget, which is incorporated by this
14		reference, in the amount of \$37,500.00 to be funded by the Arizona Department of
15		Health Services; and
16	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
