4		that "[a]ll expenditures of these funds shall be pursuant to appropriations or	
5		budgets" authorized by resolution or ordinance (Constitution of the Tohono	
6		O'odham Nation, Article VI, Section 1(d)(2)); and	
7	WHEREAS,	the FY 2018 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget in the amount of	
8		\$198,417.84 was approved by Resolution No. 17-475; and	
9	WHEREAS,	Hewel Ni'ok has prepared and submitted for review and approval its FY 2018	
10		KOHN CPB CSG Unrestricted Budget Amendment No. 1, which is incorporated by	
11		this reference and which will adjust operational line items; and	
12	WHEREAS,	the FY 2018 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget Amendment No. 1	
13		will increase the Hewel Ni'ok FY 2018 KOHN CPB CSG Unrestricted Budget by	Ì
14		\$804.80 from \$198,417.84 to \$199,222.64; and	
15	WHEREAS,	the Cultural Preservation and Budget and Finance Committees have reviewed	
16		the FY 2018 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget Amendment No. 1	
17		and recommend its approval.	
18	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the	
19		FY 2018 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget Amendment No. 1	
20		effective October 1, 2017, which includes an \$804.80 increase from \$198,417.84	
21		to \$199,222.64 that shall be funded by the Nation's General Fund pending	
22		reimbursement by the grantor.	
23	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono	
24		O'odham Nation chairperson or any designated official is authorized to	
25		administer and expend the FY 2018 Hewel Ni'ok KOHN CPB CSG Unrestricted	
26		Budget as amended, provided however, that any amendments or modifications	
27		shall be submitted for prior approval by the Tohono O'odham Legislative	
28		Council.
