

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Professional Services Agreement between the Tohono O'odham
Nation and Motorola Solutions, Inc.)**

RESOLUTION NO. 17-573

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety Law Enforcement receives yearly funding from**
8 **the Bureau of Indian Affairs ("BIA") through a 638 contract; and**

9 **WHEREAS, the funding not used during a particular year is provided back to Law**
10 **Enforcement as carryover funding the next fiscal year; and**

11 **WHEREAS, the Department of Public Safety has identified funding from FY 2016 carryover**
12 **funds to complete the new K2 Core, MCC7500 Console and Emergency Call Works**
13 **911 Dispatching System; and**

14 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
15 **approval a Professional Services Agreement between the Tohono O'odham**
16 **Nation and Motorola Solutions, Inc. for the purchase, construction and**
17 **installation of the K2 Core, MCC7500 Console and Emergency Call Works 911**
18 **Dispatching System in the amount of \$997,691.10; and**

19 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the**
20 **Professional Services Agreement and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **Professional Services Agreement between the Tohono O'odham Nation and**
23 **Motorola Solutions, Inc. substantially in the form attached hereto, and**
24 **authorizes the Nation's chairperson or any designated official to execute it,**
25 **provided that any amendments or modifications shall be submitted for prior**
26 **approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27th**
28 **day of NOVEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1 (d)(2)(3)and(f) of the Constitution of the Tohono O'odham Nation, adopted**
31 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**
