

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Professional Services Agreement between Staff Care, Inc. and the
Tohono O'odham Nation)

RESOLUTION NO. 17-576

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political**
5 **subdivisions, or with private persons or organizations on all matters within the**
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**
7 **1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") currently has position**
9 **vacancies within the Nation's health care facilities; and**

10 **WHEREAS, the Professional Services Agreement between the Tohono O'odham Nation and**
11 **Staff Care, Inc. which is incorporated by this reference, provides qualified**
12 **dental personnel to provide dental services at the facilities of the TONHC; and**

13 **WHEREAS, contract staffing services will continue to provide continuity of care for the**
14 **Nation's patients during TONHC's recruitment process; and**

15 **WHEREAS, the Health and Human Services Committee of the Legislative Council has**
16 **reviewed the Professional Services Agreement between Staff Care, Inc. and the**
17 **Nation and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
19 **the Professional Services Agreement between Staff Care, Inc. and the Tohono**
20 **O'odham Nation, substantially in the form attached, and authorizes the**
21 **Chairperson of the Nation to sign the Agreement.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
23 **day of NOVEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
24 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
