## the Legislative Council is vested with the power "to establish rules and WHEREAS, procedures to regulate all meetings of the Tohono O'odham Council, standing committees, boards and special committees." (Constitution of the Tohono O'odham Nation, Article VI, Section 1(a)); and Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative WHEREAS. Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the legislative representatives may vote to hold a session in some location other than the chambers located at Sells."; and by Legislative Order No. 17-540, the Legislative Council approved holding its WHEREAS, December 7, 2017 general session at Baboquivari Unified School District Indian Oasis Elementary Intermediate School for a presentation and tour; and the Human Resources Development Committee has requested rescheduling the WHEREAS, December 7, 2017 Baboquivari Unified School District Indian Oasis Elementary Intermediate School presentation and tour for January 12, 2018. NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council reschedules its December 7, 2017 Baboquivari Unified School District Indian Oasis Elementary Intermediate School presentation and tour for January 12, 2018 with roll call beginning at 9:00 a.m.

The foregoing Order was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> day of DECEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-AGAINST; -0-NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
