

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Holding January 9, 2018 General Session at the Sonoran Desert Inn and
Conference Center in Ajo, Arizona for a Presentation and Tour by the
International Sonoran Desert Alliance)

LEGISLATIVE ORDER NO. 17-596

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative
6 Council, as amended, provides that "[a]ll Legislative Council sessions shall be
7 held at the Tohono O'odham Legislative Council chambers located in Sells,
8 Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the
9 legislative representatives may vote to hold a session in some location other
10 than the chambers located at Sells."; and

11 **WHEREAS,** the Cultural Preservation Committee has requested that the Legislative Council
12 hold its January 9, 2018 general session at the Sonoran Desert Inn and
13 Conference Center in Ajo, Arizona for a presentation and tour by the
14 International Sonoran Desert Alliance.

15 **NOW, THEREFORE, BE IT ORDERED** that the Tohono O'odham Legislative Council will hold its
16 January 9, 2018 general session at the Sonoran Desert Inn and Conference
17 Center in Ajo, Arizona for a presentation and tour by the International Sonoran
18 Desert Alliance.

19 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05TH day of
20 DECEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
21 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
22 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
23 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
25 June 18, 1934 (48 Stat.984).
