

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Agreements between the Tohono O'odham Nation and the following**  
**entities: Department of Veterans Affairs Southern Arizona VA Health Care**  
**System; RPh on the Go, Inc., Millenia Technical Solutions, Inc., Arizona**  
**PRn, LLC; and Up to Date, a Wolters-Kluwer Company)**

RESOLUTION NO. 17-612

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council  
2 with the power "to consult, negotiate and conclude agreements and contracts on  
3 behalf of the Tohono O'odham Nation with Federal, State and local governments  
4 and other Indian tribes or their departments, agencies, or political  
5 subdivisions, or with private persons or organizations on all matters within the  
6 authority of the Tohono O'odham Council." (Constitution, Article VI, Section  
7 1(f)); and

8 **WHEREAS,** the Tohono O'odham Nation ("Nation") on behalf of Tohono O'odham Nation  
9 Health Care ("TONHC") refers patients to the Department of Veterans Affairs  
10 Southern Arizona VA Health Care System ("VA") in order to provide a full  
11 complement of health care services to its patients; and

12 **WHEREAS,** the FY 2018 Intergovernmental Agreement between the VA and the Nation would  
13 improve access to care and would facilitate reimbursement by the VA to the  
14 Nation for certain health care services, specifically Direct Care Services to  
15 TONHC patients; and

16 **WHEREAS,** TONHC currently has position vacancies within the Nation's health care  
17 facilities; and

18 **WHEREAS,** continuing existing Professional Services Agreements with RPh on the Go, Inc.,  
19 and Millenia Technical Solutions, Inc., is in the best interests of the Nation as the  
20 Nation needs to continue to provide qualified health care personnel in order to  
21 provide quality health care for our patients; and

22 **WHEREAS,** entering into a new Professional Services Agreement with Arizona Prn, LLC will  
23 enable the Nation to attract new candidates for TONHC nursing positions; and

24 **WHEREAS,** entering into the Professional Services Agreement with Up to Date, a Wolters  
25 Kluwer Co., for FY 2018, will provide continuity for TONHC medical personnel as  
26 Up to Date provides critical reference materials for Med Staff and Pharmacy for  
27 medical and medication information, continuing medical education courses to  
28 maintain licensure, as well as provides printable resources for patients; and

29 **WHEREAS,** the Health and Human Services Committee of the Legislative Council has  
30 reviewed the Agreements between the Nation and the VA, the Nation and RPh on  
31 the Go, Inc.; the Nation and Millenia Technical Solutions, Inc.; the Nation and  
32 Arizona PRn, LLC; and the Nation and Up to Date, a Wolters Kluwer Company;  
33 and recommends the approval of each Agreement.

1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves  
2 the FY 2018 Agreements between the Nation and the VA, the Nation and RPh on  
3 the Go, Inc.; the Nation and Millenia Technical Solutions, Inc.; the Nation and  
4 Arizona PRn, LLC; and the Nation and Up to Date, a Wolters Kluwer Company;  
5 substantially in the forms attached, and authorizes the Chairperson of the  
6 Nation to enter into and sign the Agreements and Amendments.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>  
8 day of DECEMBER, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;  
9 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
10 Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the  
11 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
13 June 18, 1934 (48 Stat.984).
