

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Office of the Treasurer Budget Amendment No. 2)**

RESOLUTION NO. 19-051

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Office of the Treasurer Budget in the amount of \$851,766.66 was**
8 **approved by Resolution No. 18-296, and amended by Resolution No. 19-029 in the**
9 **amount of \$1,174,059.51; and**

10 **WHEREAS, the Office of the Treasurer has prepared and submitted for review and approval**
11 **its FY 2019 Office of the Treasurer Budget Amendment No. 2 which is incorporated**
12 **by this reference and which will adjust operational and/or personnel line items;**
13 **and**

14 **WHEREAS, the FY 2019 Office of the Treasurer Budget Amendment No. 2 will increase the FY**
15 **2019 Office of the Treasurer Budget by \$39,167.00 from \$1,174,059.51 to**
16 **\$1,213,226.51; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Office of the**
18 **Treasurer Budget Amendment No. 2 and recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY**
20 **2019 Office of the Treasurer Budget Amendment No. 2 effective October 1, 2018,**
21 **which includes a \$39,167.00 increase from \$1,174,059.51 to \$1,213,226.51 that**
22 **shall be funded by the Nation's general fund surplus.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Office of the Treasurer Budget as amended, provided**
26 **however, that any amendments or modifications shall be submitted for prior**
27 **approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
29 **day of FEBRUARY, 2019 at a meeting at which a quorum was present with a vote of 2,232.85 FOR;**
30 **851.75 AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council**
31 **by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted**
32 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**
