

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Water Resources Department BIA Budget Amendment No. 1)**

RESOLUTION NO. 19-104

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Water Resources Department BIA Budget in the amount of**
8 **\$115,525.29 was approved by Resolution No. 18-299; and**

9 **WHEREAS, the Tohono O'odham Nation Grants and Contracts Office has identified FY 2018**
10 **Water Resources Department BIA Budget carry-forward funds in the amount of**
11 **\$14,144.32; and**

12 **WHEREAS, the Water Resources Department has prepared and submitted for review and**
13 **approval its FY 2018 BIA Budget Amendment No. 1, which is incorporated by this**
14 **reference and which will adjust operational and/or personnel line items; and**

15 **WHEREAS, FY 2019 Water Resources Department BIA Budget Amendment No. 1 will increase**
16 **the FY 2019 Water Resources Department BIA Budget by \$14,144.32 from**
17 **\$115,525.29 to \$129,669.61; and**

18 **WHEREAS, the Water Resources and Budget and Finance Committees have reviewed the FY**
19 **2019 Water Resources Department BIA Budget Amendment No. 1 and recommend**
20 **its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY**
22 **2019 Water Resources Department BIA Budget Amendment No. 1 effective**
23 **October 1, 2018, which includes a \$14,144.32 increase from \$115,525.29 to**
24 **\$129,669.61 that shall be funded by FY 2018 carry-forward funds.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
26 **Tohono O'odham Nation chairperson or any designated official is authorized to**
27 **administer and expend the FY 2019 Water Resources Department BIA Budget as**
28 **amended, provided that any amendments or modifications shall be submitted**
29 **for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
31 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
