7		making recommendations to the Legislative Council regarding the eligibility of
8		applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and
9	WHEREAS,	Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
10		O'odham Legislative Council shall determine whether an application is approved
11		for membership and its determination, along with the resolution number and
12		date of enactment, shall be provided to the applicant; and
13	WHEREAS,	the Enrollment Program has received the official documents showing the legal
14		name changes of enrolled members due to a variety of reasons, such as marriage,
15		divorce, or legal adoption; and
16	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 15-82, 86-
17		82, 131-84, 93-033, 93-360, 94-154, 94-459, 95-366, 97-460, 98-034, 98-174, 99-311,
