

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Senior Services Arizona Long Term Care Systems Budget Amendment No. 1)**

RESOLUTION NO. 19-258

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Health and Human Services Division of Senior Services
8 Arizona Long Term Care Systems ("ALTCS") Budget in the amount of \$586,077.00
9 was approved by Resolution No. 18-324; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2019 Division of Senior Services ALTCS Budget
12 Amendment No. 1, which is incorporated by this reference and which will adjust
13 operational and/or personnel line items; and

14 **WHEREAS,** the FY 2019 Department of Health and Human Services Division of Senior Services
15 ALTCS Budget Amendment No. 1 will decrease the FY 2019 Division of Senior
16 Services ALTCS Budget by \$45,647.00 from \$586,077.00 to \$540,430.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2019 Department of Health and Human Services Division of
19 Senior Services ALTCS Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2019 Department of Health and Human Services Division of Senior Services
22 Arizona Long Term Care Systems Budget Amendment No. 1 effective October 1,
23 2018, which includes a \$45,647.00 decrease from \$586,077.00 to \$540,430.00.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2019 Department of Health and Human Services Division of Senior
27 Services Arizona Long Term Care Systems Budget as amended, provided that any
28 amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
31 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR -0-**
32 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
