12		Amendment No. 1, which is incorporated by this reference and which will adjust
13		operational and/or personnel line items; and
14	WHEREAS,	the FY 2019 Department of Health and Human Services Division of Senior Services
15		ALTCS Budget Amendment No. 1 will decrease the FY 2019 Division of Senior
16		Services ALTCS Budget by \$45,647.00 from \$586,077.00 to \$540,430.00; and
17	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
18		reviewed the FY 2019 Department of Health and Human Services Division of
19		Senior Services ALTCS Budget Amendment No. 1 and recommend its approval.
