

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Child Care and Development
Fund Discretionary Budget Amendment No. 2)

RESOLUTION NO. 19-262

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Education Child Care and Development Fund
8 Discretionary Budget in the amount of \$678,073.00 was approved by Resolution
9 No. 18-309 and subsequently amended by Resolution No. 19-141 in the amount of
10 \$2,926,268.00; and

11 **WHEREAS,** the Department of Education has prepared and submitted for review and
12 approval its FY 2019 Child Care and Development Fund Discretionary Budget
13 Amendment No. 2, which is incorporated by this reference and which will adjust
14 operational and/or personnel line items; and

15 **WHEREAS,** the FY 2019 Department of Education Child Care and Development Fund
16 Discretionary Budget Amendment No. 2 will not change the total budget amount
17 of \$2,926,268.00; and

18 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
19 reviewed the FY 2019 Department of Education Child Care and Development Fund
20 Discretionary Budget Amendment No. 2 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2019 Department of Education Child Care and Development Fund
23 Discretionary Budget Amendment No. 2 effective October 1, 2018, in the amount
24 of \$2,926,268.00 that shall be funded by the Nation's general fund pending
25 reimbursement from the grantor.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend the FY 2019 Department of Education Child Care and Development Fund
29 Discretionary Budget as amended, provided that any amendments or
30 modifications shall be submitted for prior approval by the Tohono O'odham
31 Legislative Council.
