

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment to the FY 2019 Attorney Contract between the Tohono
O'odham Nation and Yoder & Langford, P.C. Regarding 401(k) Matters)**

RESOLUTION NO. 19-275

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to employ legal counsel for the protection and advancement of the**
3 **Tohono O'odham Nation ..." (Constitution, Article VI, Section 2(a)); and**
4 **WHEREAS, the Tohono O'odham Nation has for several years contracted with the law firm of**
5 **Yoder & Langford, P.C. for legal services related to the Nation's 401(k) Plan in**
6 **order to assist the 401(k) Plan Trustees and the Nation's Human Resources**
7 **Department; and**
8 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 19-015 approved the**
9 **FY 2019 Attorney Contract with the law firm of Yoder & Langford, P.C. regarding**
10 **401(k) matters in the amount of \$10,000 for the period of October 1, 2018 through**
11 **September 30, 2019; and**
12 **WHEREAS, the Human Resources Department has determined that additional legal**
13 **assistance is required during the current fiscal year with regards to the 401(k)**
14 **Plan; and**
15 **WHEREAS, the Human Resources Department has prepared and submitted for review an**
16 **amendment to the FY 2019 Attorney Contract with Yoder & Langford, P.C.**
17 **regarding 401(k) matters to increase the budget amount from \$10,000 to \$25,000**
18 **for the period of October 1, 2018 through September 30, 2019; and**
19 **WHEREAS, the Attorney Contract regarding 401(k) matters is under the oversight of the**
20 **Attorney General, but is paid for by the Human Resources Department Budget;**
21 **and**
22 **WHEREAS, the Human Resources Development and Domestic Affairs Committees have**
23 **reviewed the Amendment to the Attorney Contract and recommend its approval.**
24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **Amendment to the FY 2019 Attorney Contract between the Tohono O'odham**
26 **Nation and Yoder & Langford, P.C. regarding 401(k) matters in the amount of**
27 **\$25,000 for the period of October 1, 2018 through September 30, 2019.**
28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the funding for the**
29 **Attorney Contract shall be provided from the Human Resources Budget and that**
30 **the Nation's Chairperson is authorized to execute the Amendment to the Attorney**
31 **Contract in substantially the form attached.**
