

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Department of Public Safety Tribal Employment Rights Office**  
**Administration Budget TERO Commission Revenue Funding)**

**RESOLUTION NO. 19-306**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**  
8 **approval its FY 2020 Tribal Employment Rights Office ("TERO") Administration**  
9 **Budget, which is incorporated by this reference, in the amount of \$673,534.14, of**  
10 **which \$377,179.12 is to be funded by the Nation's general fund, and \$296,355.02 is**  
11 **to be funded from TERO Commission revenue funding; and**

12 **WHEREAS, the portion of the FY 2020 Department of Public Safety Tribal Employment Rights**  
13 **Office Administration Budget funded by the Nation's general fund is addressed by**  
14 **separate resolution; and**

15 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
16 **reviewed the FY 2020 Department of Public Safety Tribal Employment Rights**  
17 **Office Administration Budget TERO Commission revenue funding and**  
18 **recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2020 Department of Public Safety Tribal Employment Right Office**  
21 **Administration Budget TERO Commission revenue funding effective October 1,**  
22 **2019 in the amount of \$296,355.02.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2020 Department of Public Safety Tribal Employment Rights Office**  
26 **Administration Budget TERO Commission revenue funding, provided that any**  
27 **amendments or modifications shall be submitted for prior approval by the**  
28 **Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
30 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,057.9 FOR; 117.8**  
31 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat.984).**
