10		which \$377,179.12 is to be funded by the Nation's general fund, and \$296,355.02 is
11		to be funded from TERO Commission revenue funding; and
12	WHEREAS,	the portion of the FY 2020 Department of Public Safety Tribal Employment Rights
13		Office Administration Budget funded by the Nation's general fund is addressed by
14		separate resolution; and
15	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
16		reviewed the FY 2020 Department of Public Safety Tribal Employment Rights
17		Office Administration Budget TERO Commission revenue funding and
18	1	recommend its approval.
