

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Office of Attorney General SAWRSA Trust Fund Budget)**

RESOLUTION NO. 19-316

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Office of Attorney General has prepared and submitted for review and  
8 approval its FY 2020 SAWRSA Trust Fund Budget, which is incorporated by this  
9 reference, in the amount of \$675,000.00 to be funded from the SAWRSA Trust  
10 Fund; and


11 **WHEREAS,** the Domestic Affairs, Water Resources, and Budget and Finance Committees have  
12 reviewed the FY 2020 Office of Attorney General SAWRSA Trust Fund Budget and  
13 recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
15 FY 2020 Office of Attorney General SAWRSA Trust Fund Budget effective October 1,  
16 2019 in the amount of \$675,000.00, which shall be funded by the SAWRSA Trust  
17 fund.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
19 Nation chairperson or any designated official is authorized to administer and  
20 expend the FY 2020 Office of Attorney General SAWRSA Trust Fund Budget,  
21 provided that any amendments or modifications shall be submitted for prior  
22 approval by the Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
24 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 2,936.8 FOR; 238.9**  
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat.984).**
